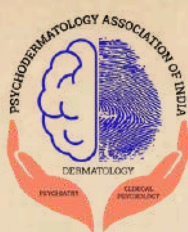

TERMS AND CONDITIONS

1. Sponsorship Confirmation

Participation in PSYDERMCON 2026 shall be confirmed only upon receipt of an official communication (email or letter) from the sponsoring organization addressed to the Organizing Secretary, clearly specifying the category and nature of participation.

A minimum advance payment of **70% of the sponsorship amount** is required at the time of confirmation. Sponsorship benefits shall be activated only after receipt of the applicable advance payment.

2. Stall Booking & Branding

Sponsors opting for exhibition stalls must provide the exact company name to be displayed on the stall fascia at the time of booking confirmation.

Stall allocation shall be made on a first-come, first-served basis and shall remain at the sole discretion of the Organizing Committee.

3. Submission of Artwork & Promotional Materials

All advertisements, artwork, logos, promotional materials, inserts, and branding creatives must be submitted to the Organizing Secretary no later than **20 days prior to the conference commencement date**.

All promotional materials, delegate giveaways, gifts, product samples, and food items intended for distribution during the conference must receive prior written approval from the Organizing Committee.

The Organizing Committee shall not be responsible for editing, proofreading, redesigning, or retouching any submitted artwork or promotional material.

4. Official Event Vendor

5. Stall Construction & Venue Regulations

Exhibitors may decorate and utilize their allotted stalls only after official handover by the Organizing Committee.

No structural modifications, drilling, painting, nailing, or alteration causing damage to the venue property shall be permitted.

Requests for additional furniture, fittings, electrical connections, internet services, audio-visual equipment, or special requirements must be submitted in advance and shall be charged separately.

6. Transportation & Permissions

Exhibitors shall be solely responsible for obtaining all necessary permits, permissions, insurance coverage, and approvals required for the transportation, installation, display, operation, and removal of exhibition materials and equipment.

The Organizing Committee shall not be liable for any loss, theft, damage, delay, or regulatory issues relating to exhibitor materials.

7. Conference Dinner Invitations

Subject to availability and sponsorship category, Regional Managers and above may be invited to attend the official Conference Dinner.

Conference Dinner invitations are strictly non-transferable and must be collected from the Organizing Secretariat upon presentation of appropriate identification.

8. Occupation of Exhibition Space

Sponsors must occupy their allotted stall space within the timelines communicated by the Organizing Committee.

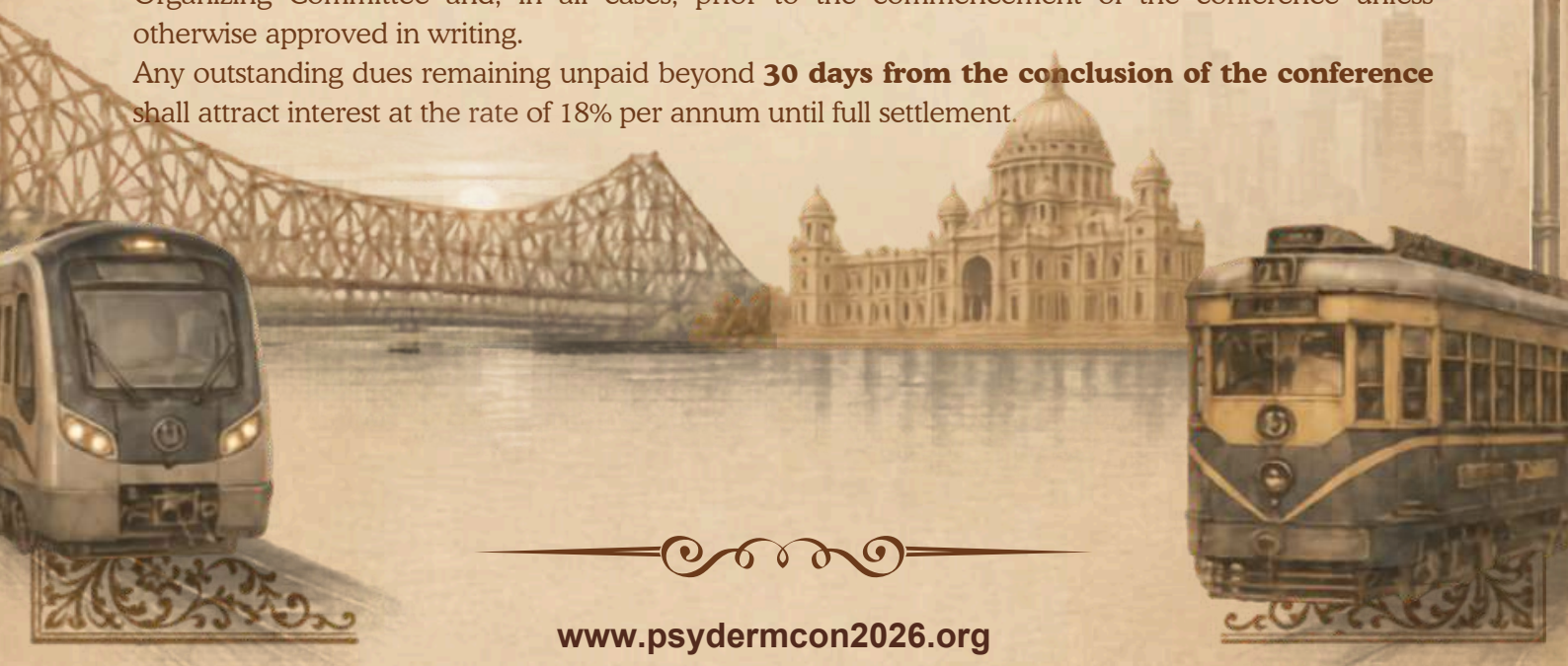
Any stall space remaining unoccupied beyond the designated setup period on Day 1 of the conference may be deemed forfeited.

The Organizing Committee reserves the right to reallocate such space without notice and without any obligation for refund or compensation.

9. Payment Terms

The balance sponsorship amount shall be payable as per the payment schedule communicated by the Organizing Committee and, in all cases, prior to the commencement of the conference unless otherwise approved in writing.

Any outstanding dues remaining unpaid beyond **30 days from the conclusion of the conference** shall attract interest at the rate of 18% per annum until full settlement.

10. Cancellation & Refund Policy

11. Taxation

No final GST invoice shall be issued against partial or unrealized payments.

13. Force Majeure

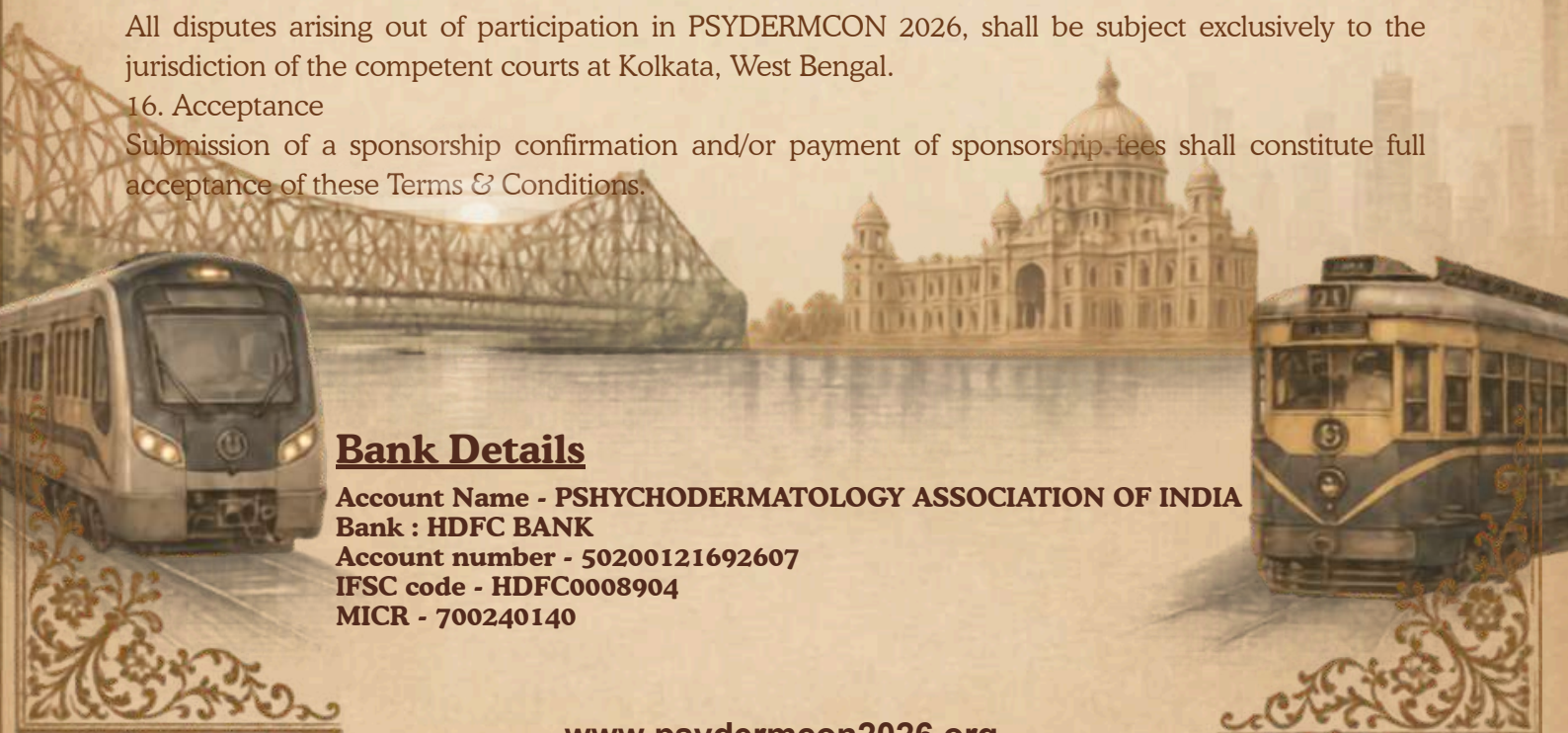
